

## MEMBERSHIP CLASSIFICATIONS 2010

All Lake Bracken Country Club memberships are annual memberships beginning January 1st of each year.

### **Full Membership**

Includes all Club activities for the immediate family. Non-married couples must live at the same address to qualify for this membership. Commencing January 1, 1990, required membership for all new Lake Bracken homeowners and renters.

### **Junior Full Membership**

Includes all Club activities for the immediate family when the primary membership age is under 33. Non-married couples must live at the same address to qualify for this membership.

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

### **Single Membership**

Includes all Club activities for an unmarried person with no dependents, or any person, married or unmarried, with or without dependents, who will be the sole user of the facilities.

### **Social Membership**

Includes all Club activities except golf for the immediate family. Non-married couples must live at the same address to qualify for this membership. Minimum required membership for Lake Bracken homeowners and renters prior to January 1, 1990.

**Clubhouse Membership**

Includes all Clubhouse activities for the immediate family. Non-married couples must live at the same address to qualify for this membership.

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

**Junior I Membership**

Includes all Club and Pool activities for a single member age 8 through 18.

\$505.00 per year

**Junior II Membership**

Includes all Club and Pool activities for a single member age 19 through 26.

\$775.00 if prepaid by January 31, of the current membership year or \$70.00 monthly.  
\$15.00 Monthly Food & Beverage Minimum

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

**Junior III Membership**

Includes all Club and Pool activities for a single member age 27 through 32.

\$880.00 if prepaid by January 31, of the current membership year or \$80.00 monthly.  
\$15.00 Monthly Food & Beverage Minimum

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

**Non-Resident Lake Bracken Homeowner**

Available to Lake Bracken homeowners not residing on the homesite property and not using any of the club facilities. This is a membership that has been created for members owning homes that are either being sold on contract or rented. Applications are available at the LBCC Office

\$450.00 per year

A \$150.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

**Non-Resident Golf Membership**

Includes all Club activities for the immediate family. Must reside outside a 40-mile radius of Lake Bracken Country Club. Tee times for weekend and holiday play are not available for these members; however, they may play with a group who has a tee time.

\$30.00 Monthly Food & Beverage Minimum

A \$150.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership.

**Special Activity Membership**

Includes use of the lake (including the privilege to fish) and trails for the immediate family.

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership

**Full Pool Membership**

Includes use of the pool and park for the immediate family.

\$360.00 per year

A \$100.00 Special Improvement Fee due May 1<sup>st</sup> of each year for this membership

**Junior Pool Membership**

Includes use of the pool and park for a single member age 8 through 18.

**Definitions:**

Immediate family includes all members living in the household including dependent children through age 19 (through age 23 if full-time student).

All ages are determined January 1<sup>st</sup> of the current membership year.

The Food & Beverage Minimum is a minimum fee to be spent on food and/or beverages in the club restaurant, all snack-bars, and the bar on a monthly basis, March through November. There is no Minimum requirement for the months of December, January, and February.

Full Time Student (12 hours of class instruction) proof is required with new membership or re-certification application. Proof of shall include a copy of a current report card or transcript that indicates total credit hours. Grades may be blocked out the report card or transcript.
